

SECTION 7 **AGRICULTURAL INSTITUTIONAL (AIN) ZONE REGULATIONS**

The Agricultural Institutional (AIN) Zone is intended to apply to lands designated “Institutional” in the rural areas outside of Settlement Areas and, as well as areas designated “Agricultural Resource Area” in the Official Plan.

7.1 PERMITTED USES

No land shall be used and no buildings or structures shall be erected, used, or altered in the Agricultural Institutional (AIN) Zone except for the following purposes:

- Cemetery;
- Church or Place of Worship;
- Small-scale school, public or private;
- Accessory uses to the above permitted uses.

7.2 MINIMUM LOT AREA

No municipal water supply or sanitary sewage disposal service:	2,045 m ²
Partial municipal services (water or sanitary sewer):	1,060 m ²
Full municipal water and sanitary sewage disposal services:	560 m ²

7.3 MINIMUM LOT FRONTAGE

No municipal water supply or sanitary sewage disposal service:	30.0 m
Full municipal water and sanitary sewage disposal services:	25.0 m

7.4 MAXIMUM LOT COVERAGE

50 %

7.5 MAXIMUM BUILDING HEIGHT

12.0 m

7.6 MINIMUM FRONT YARD DEPTH

Abutting a commercial or industrial zone:	15.0 m
All other cases:	7.5 m

7.7 MINIMUM SIDE YARD WIDTH

Abutting a commercial or industrial zone:	7.5 m
Exterior Side Yard	6.0 m
All other cases:	4.5 m

7.8 MINIMUM REAR YARD DEPTH

7.5 m

7.9 EXCEPTIONS – AGRICULTURAL INSTITUTIONAL (AIN) ZONE

7.9.1

Defined Area

AIN-2 as shown in Schedule “A”, Map 22 to this By-law

Additional Permitted Uses

Single detached residence, subject to the following regulations:

Minimum lot area	0.4 hectares
Minimum lot frontage	60.0 metres
Minimum front yard depth	10 metres
Minimum side yard (exterior)	5.0 metres
Minimum rear yard	7.5 metres

For the purposes of MDS setback requirements this property shall be considered a Type A land use as long as the site is used for residential purposes.
