BY-LAW NUMBER 21/2023

BEING A BY-LAW TO AMEND BY-LAW NUMBER 4/2021 BEING A BY-LAW TO REGULATE TRAFFIC & PARKING ON HIGHWAYS UNDER THE JURISDICTION OF THE CORPORATION OF THE TOWNSHIP OF WELLESLEY

WHEREAS the Council of the Corporation of the Township of Wellesley has adopted Traffic & Parking By-law No. 4/2021, as amended;

AND WHEREAS the Council of the Corporation of the Township of Wellesley deems it necessary and expedient to amend Parking By-law No. 4/2021, as amended;

Now therefore be it resolved the Council of the Corporation of the Township of Wellesley enacts as follows:

Definitions:

ADD:

- 1) "Snow Event" means a specific window of time when significant snow fall with accumulation of 8cm or more is forecast or has already occurred and the director of Public Works or his/her designate has declared the "snow event".
- 2) "Significant Weather Event" means an approaching or occurring weather hazard with the potential to pose a significant danger to users of the highways within a municipality

REVISE:

Part III, Enforcement and Authority #2 e)

"The by-law enforcement officer, the director of public works and/or his/her designate may authorize specific exemptions to the overnight parking restriction when a written request for a rate payer is received and a thorough review indicates that there are no obvious health and safety concerns being compromised"

Part V, Parking and Stopping Restrictions #3 a) xiv) Parking Prohibited "between the hours of 4:00 a.m. and 9:00 a.m. between December 1st and March 31st;"
